AIR TRAVEL INFORMATION

You will fly into **San Jose Del Cabo International Airport (SJD)**, which is approximately 40 minutes from the Sheraton Grand Los Cabos Hacienda Del Mar.

PASSPORT REQUIREMENTS & IMMIGRATION

ALL PERSONS traveling by air between the United States and Mexico are required to present a valid passport to enter or re-enter the United States.

We suggest you allow a minimum of two to three months to obtain or renew your passport. Generally, your passport cannot expire within 6 months after the date of your trip; however, each country varies, so check with your local passport agency to verify. Children must also have valid passports. Children traveling with an adult other than their parent or with only one parent must carry notarized written permission from any parent or guardian not traveling with the child to or from Mexico. This permission must include the name of the parent, the name of the child, the name of anyone traveling with the child, and the notarized signature(s) of the absent parent(s). The State Department recommends that the permission should include travel dates, destinations, airlines, and a brief summary of the circumstances surrounding the travel. The child must be carrying the original letter – not a facsimile or scanned copy – as well as proof of the parent/child relationship (usually a birth certificate or court document) – and an original custody decree, if applicable.

If you have adopted children, please be sure to have your adoption papers with you.

If you live in the United States and are not a U.S. citizen, we recommend that you check with U.S. Immigration regarding your particular situation.

Upon your arrival in Mexico you will go through both immigration and customs and upon your departure you will have to clear U.S. customs and immigration at your first point of entry back into the U.S.

GROUND TRANSPORTATION OPTIONS

Option #1 – Taxis

Taxis hold up to four passengers and cost approximately \$80 USD one-way. You will be approached by many taxi drivers in the airport and while taxis are widely available, many are not metered, so agree on your price before you get in.

Option #2 – Personalized Transportation

If you prefer, we have arranged with Mexico Incentives & Meetings, DMC (MI & M), our selected tour company in Los Cabos, to provide Symposia Medicus conference members with transportation to/from the Sheraton Grand Los Cabos Hacienda Del Mar.

When booking online, you will choose Group Transportation. You will then enter your contact and flight information and hit the submit button. You will be taken to the payment page and need to click on the button *Buy Now*. You will be taken to a PayPal page where you can log in (if you have an account) or you can click on the *Pay with Debit or Credit Card* option. If you do not complete the payment section, your transportation will not be reserved, even if you have received the email confirmation.

Non-private Group Transportation Rates:

- \$20.00/person, plus \$3.00 gratuity, one-way
- \$40.00/person, plus \$6.00 gratuities, round-trip

After you get off the plane in Los Cabos, you will pick-up your luggage and pass through Customs. Just outside the International arrival gate, look for uniformed MI & M representatives. They will be wearing GREEN shirts with beige pants and holding signs that say "Symposia Medicus." You will give the MI & M representative your name and they will assist you with your luggage and escort you to a waiting transport vehicle.

At the conference, in preparation for your departure, MI & M will provide participants, one day prior to departure, with a Departure Notice Sheet that indicates your flight schedule. MI & M will have a hospitality desk outside our conference room for your convenience.

PARKING
