These appropriate valid travel documents such as passports, visas, inoculation certificates, and/or family legal documents are required for ship boarding and country entry and/or re-entry into the United States and other countries. Based on nationality, many countries require an entry visa.

Guests who do not possess the proper documentation may be prevented from boarding their flight or ship, or from entering a country, and may be subject to fines.

Note: No refunds will be given to individuals who fail to bring proper documentation.

IF YOU PURCHASE AIR ARRANGEMENTS ON YOUR OWN:

Going home, you should allow at least three hours between when the ship disembarks in Venice and your plane departs (disembarkation starts at approximately 8:00am). The three hours allow you time for ship clearance, customs clearance (if applicable), and airline security. You can also request to be one of the first groups to depart the ship by going to the Guest Relations Desk as soon as possible once you board the ship and letting them know that due to a tight airline schedule, you need to be included in the first group off the ship.

Once you have arrived, cleared customs and collected your luggage at the airport, you will be met by a Celebrity Cruises® representative outside the Baggage Claim area who will assist you with transportation to the ship. When you return from your cruise and have claimed your luggage, a Celebrity Cruises® representative on the pier will direct you to your transportation to the airport. Note: The transfers are only available on the scheduled day of ship embarkation (September 18, 2018, no later than 1:45pm) and disembarkation (September 27, 2018, no earlier than 11:10am). If your flight does not meet these requirements, you will need to arrange your own transportation, such as a taxi to/from the port.
