CONFERENCE DESCRIPTION

Our **3rd Annual Conference on Challenges in Mental Healthcare for the Primary Care Provider** is designed for physicians, certified nurse midwives, nurse practitioners, PAs, nurses, and other healthcare professionals to provide practical, evidence-based tips for treating the primary care patient with challenging psychiatric and psychosocial problems. The goal of this conference is to provide a systematic review of basic skills for dealing with behavioral issues in primary care and emphasizing the practical application of evidence-based behavioral care. The intended participant is the primary care provider who has been frustrated with trying to manage the patient with comorbid behavioral disorders which are interfering with medical/surgical treatment.
